Specific Conditions :

1. The management should start conducting the first and second year classes of the polytechnic at their permanent site for the academic year 1997-98.

The construction work of building at permanent site should be completed within 6 to 8 months.

2. The admissions to the courses i.e. Chemical Technology, Computer Technology and Mechanical Engg. should be made only after receipt of affiliation from the State Board of Technical Education.

3. AC sheets roofing plastering, Flooring, fixing of window doors . entrance doors . electrical fittings and electrical connections etc. should be completed.

4. In the drawing hall, one black board is to be provided. Each drawing table should have provision to keep instruments and books and a holder for keeping the pencil.

5. Protective vertical wire mesh partition should be provided in the middle of work tables in the carpentry and fitting shops. Carpentry shop housed in the fitting shop should be shifted to a separate place . Fitting vices should be fitted to the work tables . The height of the worktables in carpentry shop should be increased and vices should be fitted suitably.

6. In the physics lab, the work tables should be provided with electrical points, water connections, wash basins, stools and fans. Dark room and store room should be provided. The tops of the work tables should be smoothened and fitted with mica sheets.

7. In the chemistry lab, the tops of the worktables should be made acid proof. Work tables should be provided with water and gas connections . Exhaust fans . first aid box. Fire extinguishers should be provided in this lab. Gas cylinders should be kept outside the lab, for safety purpose . A store room should also be created.

8. Plumbing lab. for Chemical tech. should be created.

9. Black smithy shop should be created

10. Computer room should be augmented in terms of space and number of terminals, air conditioning and separate earthing should be provided.

11. Library space should be augmented as per norms of AICTE. Atleast 2000 books in engg. & tech. and science should be added immediately to the library. Atleast 10 periodicals should be subscribed. The books should be given accession numbers and bear the seal of the polytechnic and proper records shall be maintained.



12. Principal, HODs, teaching staff should be recruited immediately as per procedure, oualifications and experience prescribed by AICTE and gradually brought at par with the norms of AICTE.

13. A master plan for the proposed construction of various buildings of the polytechnic at the permanent site alongwith action plan for the schedule of construction year wise including the cost involved in it should be prepared and submitted within one month.

14. The adequate finances should be provided for meeting recurring and non recurring expenses of the proposed institution.

15.AICTE scales of pay alongwith applicable allowances should be granted to the teaching and non teaching faculty.

16. The institution should create an endowment fund jointly in the name of institution and the concerned State authority to the tune of 30% of the projected peak annual recurring expenditure or as prescribed by State Govt./ Union Territory or Rs. 10 lakhs, whichever is more.

17. The institute should use the proposed area exclusively for the polytechnic.

18. Infrastructural and other facilities in terms of faculty, laboratories, workshops, library etc. for the first year and subsequent years of classes should be established in the new campus well in advance before the actual commencement of that year.

19. This approval is subject to rectification of the deficiencies in terms of infrastructural facilities pointed out by the expert committee before admissions of stydents for the session 1996-97.


